West Africa port congestion

The EWATA (Europe West Africa Trade Agreement) have informed about port congestion in West African ports reaching alarming levels. The congestion along the coast is getting worse and the likes of a 30-days delay at Luanda, and 10-days-and-over at Lagos, are hitting all the shipping lines on the trade.

Please take this into account while booking shipment to any port in West Africa.

Personal effects via Montevideo

Our agents in Montevideo have informed us that they can no longer accept personal effects for further transport to destinations, served via Montevideo. Therefore we cannot accept any personal effects to the following destinations; Cordoba, Mendoza, Rosario, Chochabamba, La Paz, Santa Cruz, Caxias do Sul, Novo Hamburgo, Porte Alegre / Rio Grande and Asuncion.



Commercial invoices required

More news from our agent in Montevideo; from now on the Paraguayan Customs require a check of the commercial invoices for all cargoes with final destination Asuncion. Please make sure to provide your commercial invoice prior to shipment, in order to make sure that we would not face any problems, while forwarding your shipments into Paraguay.

Original customs documents required

Please be informed that as from January 1st, 2008 the Dutch customs will only accept original documents. Copies will be refused as from that date. So please deliver your shipments together with original export documents, otherwise you run the possibility that goods are left behind.

Reminder: Marks & Numbers

We kindly ask you once again to ensure that all cargoes are port-marked with at least the name of the consignee. The marks and numbers on the B/L have to be exactly the same as on actual cargo.

In case the B/L and/or the cargo do not indicate any marks and numbers, we will not accept any responsibility in case cargo will be switched or released to the wrong consignee.

It is compulsory in many countries for marks and numbers to be mentioned on the B/L and the cargo manifest. FYI: the term "as addressed" will no longer be accepted in Singapore.



Promo rates for services via Beirut

As per December 1st, 2007 we will reduce our rates for destinations served via Beirut. For attractive LCL rates to Lattakia and Mersin via Beirut, please contact our Customer Service department with your requests.

Dangerous Goods Declaration

We have been confronted more and more with the fact that the information on Dangerous Goods Declarations (DGD) is incorrect or incomplete. In order to minimize the risk of dangerous goods shipments being rejected and to avoid delays, we request you to adhere to the following details:

- Name of the vessel
- Port of loading
- Final port of discharge (no transshipment port)
- IMO details and references
- Signature of the shipper and packing company

Please note that the shipper is responsible for the correctness of the above mentioned details.
