## A holiday for Minouche Ros ?

Minouche Ros, our airfreight executive set off very early for Amsterdam Airport. For an exotic holiday? Not exactly. Amsterdam airport was her final destination in this case.

Minouche attended the loading of an industrial mixer with dimensions 5,00x2,70x2,90 mtrs weight 5700 kos bound for Osaka. A skid had to be ordered which was fixed to the base of the machine at the factory by our packers.

As can be seen from the photograph the mixer only had centimeters to spare in the cargo hold and had infact been turned down by other carriers due to these dimensions. Singapore Airlines and ourselves however took a calculated risk which in the end paid off.

In close concert between Singapore Airlines,our airfreight department and the manufacturers of the dryer,the maximum limitations were established whereupon the best stowposition had to be selected, resulting in the successful loading of said piece in the Boeing 747 Freighter.

And with Minouche in attendance, giving it the final touch, cargo was eventually safely delivered to the final user in Osaka.

## A request from our operational departments

Both our import as well as our export department request you to pay extra attention to the shipper, notify and consignee details. Upon sending us your bill of lading or your bill of lading instructions, please check if all required details are mentioned in the proper way.

Every party should have at least a telephone number or a faxnumber. If available please mention an e-mail address as well. This enables us to send the relevant messages to all parties concerned. These messages are booking confirmations, loading confirmations, shipping confirmations, pick up confirmations, etc.

Furthermore, the detailed information makes it easier for us to contact a certain party, which may prevent storage costs.

Additionally, we would like to inform you that we need your B/L instructions at least 1 day prior to sailing. This will help us to avoid manifest corrections and/or penalties from the carriers. Thanks a lot for your cooperation!

## Reminder:Direct representation regarding exports

As per the 6th of April 2008, the way of declaring goods for exports will change. If you want Cleve & Zonen to arrange your export declaration, you have to authorise us as a direct representative, as long as you are in the European Union. The power of attorney has to be signed by an authorised person. With one of our next issues, we will send you a specimen of the authorisation for your easy reference.

## Reminder:Marks & Numbers

We kindly request you once again to ensure that all cargoes are port-marked with at least the name of the consignee. The marks and numbers on the bill of lading have to be exactly the same as on the actual cargo.

In case the B/L and/or the cargo do not indicate any marks and numbers, we will not accept any responsibility in case cargo will be switched or released to the wrong consignee. It is compulsory in many countries for marks and numbers to be mentioned on the B/L and the cargo manifest.
