Marks and Numbers New Zealand

Please be advised that NZ Customs have made a small change to the requirements for the Marks and Numbers on all LCL cargo destined to New Zealand customers. Effective immediately, we have been advised that if there are no NZ marks on the cargo they will no longer be allowed to match up the cargo and it will be de-vanned as "extra to manifest". It will be the responsibility of our agent to match up the cargo to the correct client. This could result in delays in releasing cargo to clients.

Please check if cargo is marked correctly with New Zealand consignee and full address !

Reminder: filing for China

As of January 1st, 2009, ocean carriers have to submit their manifests to China Customs a minimum of 24 hours prior to cargo loading. This new rule is applicable to all exports, imports and transshipment cargoes via any Chinese ports (except Hong Kong and Macau).

To comply with this rule, the carriers need to have Bill of Lading instructions in time. Cleve, as a consolidator needs your cooperation in order to arrange the same. We kindly ask you to provide us with your instructions NOT later than the cargo closing (72 hours before departure of the vessel) and they should include the following details:

- A Complete name and address of the shipper
- B Complete name and address of the consignee
- C Complete name and address of the notify party
- D Precise cargo description

No cargoes should be loaded without getting loading permission from China Customs. Without loading permission, shipments will be rolled to the next available sailing.

Above legislation will again take up additional time and administration from our side and for this reason we will ask a contribution of euro 15.00 per bill of lading.
