Argentinian Customs regulations

Please be advised that Argentinian customs authorities have announced an increase in the surveillance of;

- CUIT number (this is a unique Tax Identification Code belonging to the consignee and or notify)
- NCM number(Harmonised Code)

Both items should be manifested for all shipments to Argentina. If this information is not available, Argentinian customs will not register the cargo, and accordingly cargo will be blocked. Blockage will ultimately result in delays and possible fines.

Please be so kind to supply us with the a.m. information, together with your shipping instructions. Our documentation department will contact you if this information is missing, However the shipper remains responsible FOR SUPPLYING THE INFORMATION .

Xiamen Commodity Inspection Bureau

Our Xiamen agent advises their overseas partners that the Xiamen Commodity Inspection Bureau will supervise all incoming groupage containers during devanning. As a result devanning may take longer .

The bureau will mainly check the following;

- 1) Cross check on actual Marks and Numbers on packages and house bill of lading.
- 2) Cross check if packaging mentioned on the bill of lading matches actual
- 3) If applicable, Fumigation ISPM 15 marking on wooden packaging.
- 4) Cross check of the mentioned quantity on the bill of lading with actual.

Please ensure that your B/L instructions are complete and match in every aspect the cargo loaded. To avoid unnecessary delays please pay special attention to the marks and numbers as this is one area where discrepancies are commonest.

Personal effects to Vietnam

Please take note of the regulations and documentation covering the import of personal effects to Vietnam. The name of shipper and consignee on the HB/L must be identical. The Government of The Socialist Republic of Vietnam does not allow Vietnamese citizens to import used personal effects.

Documents requested:

- 1) a copy of the passport
- 2) the White paper (original) / Immigration paper
- 3) an original Letter of Authorization from Consignee authorizing GLOBELINK VIETNAM to proceed with Customs clearance. This authorization must be accompanied by a stamped and signed letter of confirmation from consignees intended employer
- 4) the Labour contract / work permit of consignee if intending to work in Ho Chi Minh
- 5) packing list of this shipment
- 6) temporary Residence paper at Ho Chi Minh (at address mentioned on BL as consignee party)

Opening hours CFS and office

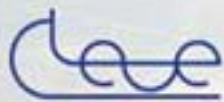
We kindly request you to note following opening and closing hours in Rotterdam during the month of April:
