### SUSPENSION OF ABIDJAN SERVICE

With immediate effect, Cleve & Zonen has to suspend the services to and from Ivory Coast due to EU Council regulation 25/2011.

The suspension is applicable for all cargo destined for Ivory Coast and is valid until further notice.

Cleve & Zonen reserves the right to relinquish all responsibility to the shipper if, under any circumstance, a shipment destined for Ivory Coast is shipped via Cleve & Zonen.

### LCL SERVICE TO SHANTOU

We are pleased to announce that the suspension of the LCL service from Hong Kong to Shantou has been lifted. With immediate effect, we can again accept LCL shipments for Shantou. Please note that acceptance of dangerous goods must be reviewed on a case by case basis.

### SERVICE TO TRIPOLI SUSPENDED

Please be informed that due to the current situation in Libya, our service to Tripoli is suspended till further notice.

### NON ACCEPTED COMMODITIES

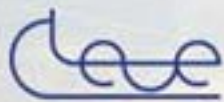
We would like to remind you that there are a few commodities which we cannot accept for shipment (import or export).

The list of non accepted commodities can be found on our website [www.cleve.nl/nonacceptance.html](http://www.cleve.nl/nonacceptance.html) and includes the following:

- *Precious metals (such as Molybdenum, Ferro Molybdenum, Cobalt, Ruthenium, Rhodium)*
- *Hazardous goods with IMO class 1 and 7*
- *Hazardous goods with IMO sub-label 1 and 7*
- *Lithium batteries*
- *Calcium Hypochloride and other types of chlorides*
- *Metallic Mercury (or Quicksilver)*
- *Weapons and/or ammunition*
- *Cigarettes, cigars and tobacco (products)*
- *Alcoholic beverages with an alcohol percentage exceeding 8% (wines are accepted / other beverages only acceptable under special conditions)*
- *Jewelry, coins and precious stones*
- *Antiques*
- *Human remains, livestock or plants*
- *Scrap cargo (such as metal scrap, waste paper) to some destinations*

### BANNED COMMODITIES TO SUDAN

According to the decree of the Ministry of Foreign Trade no 2/2011, the Central Bank of Sudan has issued a resolution which bans imports of the following commodities:

- Furniture (all kinds)
- Fresh and frozen meat
- Cattle
- Mineral water and soft drinks
- Products made of flour (e.g. biscuits and macaroni)
- Skins and leather
- All kinds of silk
- Milk products and eggs
- Plastic products (e.g. plastic flowers)
- Used cars
- Paints
- Tobacco
- Umbrellas and sticks
- Sugar Cane, straws and cane products
